### Blue Card Volunteer Application:

Step1: **Register for online account:**

Step2: **LINK your Blue Card account** to Surf Life Saving Queensland (SLSQ);

*This step is required so we can link your card to SLSQ, to enable you to apply as a volunteer (and have the application fee waived). IF YOUR CARD IS ALREADY LINKED TO SLSQ YOU CAN SKIP THIS STEP.*

Step3: Once you receive notification from Blue Card Services to confirm you have been linked to SLSQ:
