



# CLUB CRAFT STORAGE POLICY

## Purpose

The purpose of this policy is to provide clear guidelines with respect to craft storage that Mooloolaba SLSC adheres to out of fairness.

Due to the number of members and limited storage space available, it is important that a priority is placed on storage spaces for craft with Lifesaving and Competition purposes in mind.

MSLSC provide rescue boards for specific lifesaving training to help minimise the number of additional craft at the premises.

MSLSC are prioritising the limited storage space we have for personal craft for competition purposes. There are morning and afternoon endorsed training for this craft, which is open to all members and age groups.

## Application

This policy applies to all Members and Age Groups.

## Policy

All members wanting to store craft will be required to complete the online application – craft make, colour and serial number must be provided.

To be eligible for storage at MSLSC Clubhouse the following criteria must be applicable:

- Must be a financial and proficient member
- Craft must be SLSA endorsed craft (no other boards or ocean skis)
- Meet all patrol obligations as determined by the Club Captain
- Subject to the members craft requirements, only one item of each craft at a maximum is to be stored

Existing members will be given priority; there will be a requirement for new members to demonstrate commitment to the club.

Of the existing members, the priority shall be as follows (with cadets and youth remaining highest priority):

1. Club craft – lifesaving and competition
2. Cadets
3. Youth
4. Regular attendance using craft that is stored (at least 2 times per week) in club endorsed training sessions e.g. if storing ski, at least 2 x ski sessions per week are required.
5. Carnival representation in current season
6. Opens

7. Coaches
8. Active patrolling members who participate in training, water safety, competition and other club activities
9. Long service members who participate in patrols, training, water safety, competition and other club activities and carnivals
10. Life members and office bearers

### **Breach**

The following are deemed breaches and will result in the removal of storage entitlements whereby a timing of 2 weeks will be given to remove the craft from storage (and further taken to MSLSC Smith Street storage facility to be collected):

- Code of conduct breach
- Not adhering to all criteria items listed above
- Dormant craft sitting in storage

### **Further items**

- Craft is stored at the owner's risk.
- Craft will be stored in the allocated storage rack as allocated by the Club Captain, DoSS and Gear Steward. At no time should craft be placed in another person's rack.
- Several spaces may be left unallocated as a contingency for the club.
- Craft is to be washed down following each session and stored in the allocated rack only in a clean condition free of sand.
